 Anything to be UNSAFE: I will immediately take all precautions to avoid the unsafe area and REFUSE TO PARTICIPATE further.
- 2. I/We fully understand and acknowledge that:
 - A. There are risks and dangers associated with participation to Martial Arts events and activities which could result in Bodily injury partial and/or total disability, paralysis and death.
 - B. The social and economic losses and/or damage which could result form these risks and dangers described above could be severe
 - C. These risks and dangers may be caused by the action, inaction or negligence of the participant or the action, inaction or negligence Of others, including,, but not limited to the releases named below.
 - D. There may be other risks not know to us or are not reasonable foreseen at this time.
- 3. I, We accept and assume such risks and responsibility for the and/or damages following such injury, disability, paralysis or death, however Caused and whether caused in whole or part by the negligence of the releases named below.

I/We HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the Martial Arts Facility used by the participant, Including its owners, managers, promoters, lessees of premises used to conduct the Martial Arts Event or programs, premises and event inspectors, underwriters, consultants and others who give recommendations, directions or instructions to engage in risk evaluation Or loss control activities regarding the Martial Arts facility or events held at such facility and each of them, their directory, officers, agents Employees, all for the purpose herein referred to as "Release" From all liability to the undersigned, my/our personal representatives, assigns, Executors, heirs and next of kin for any and all claims, demands, losses or damage and any claims of demands therefore on account of any Injury and/or death and/or property damage.
